Foreigners can file a lawsuit with the regional court against a decision to terminate the proceedings pursuant to §25 and against a decision to reject the asylum application as a manifestly unfounded claim pursuant to §16(1)(d) and (e) of the Asylum Act. These lawsuits are without a suspensive effect of appeals.

(1) - Regional Court in Prague, Brno, Ostrava, Hradec Kralove, Usti nad Labem, Ceske Budejovice, Plzen, Hradec Kralove - branch office in Pardubice, Usti nad Labem - branch office in Liberec, Metropolitan Court in Prague
