After receiving a negative decision of the Regional Court (after the decision becomes legally effective), the person ceases to be an applicant for international protection. The foreigner can file a cassation complaint to the Supreme Administrative Court in Brno against the decision of the Regional Court. Having fulfilled the statutory conditions, he/she can be issued a visa for the purpose of a leave to remain in the territory.

\* Number of foreigners who filed a cassation complaint – number of foreigners in whose cases the decisions on cassation complaints have not become legally effective yet.

\*\* Decisions issued with legal effect = this column also contains decisions on cases filed in previous periods that were processed during the given period.

Negative decisions - include suits dismissed and proceedings discontinued.

Note: Only cassation complaints of which the MOI had been informed by the courts are registered
