After receiving a negative decision of a Regional Court (after the decision comes into force) the person ceases to be a seeker of international protection. The foreigner can file a cassation complaint to the Supreme Administrative Court in Brno against the decision of the Regional Court. Having fulfilled the statutory conditions, he/she can be issued a leave to remain.

* Number of foreigners who filed a cassation complaint – Number of cases of cassation complaints where the verdicts have not come into force yet.

** Verdicts handed to foreigners = This column also contains older verdicts which were handed to the foreigners during the given period.
