Foreigners can file a suit with the regional court against a decision to terminate the proceedings pursuant to Section 25 and against a decision to reject the asylum application as a manifestly unfounded claim pursuant to Section 16(1)(d) and (e) of the Asylum Act; these suits are without suspensive effect.

(1) - Regional Court in Praha, Brno, Ostrava, Hradec Kralove, Usti nad Labem, Ceske Budejovice, Plzen, Hradec Kralove - branch office in Pardubice, Usti nad Labem - branch office in Liberec, Metropolitan Court in Praha

\* The number of foreigners with a suit without suspensive effect = this includes persons whose cases the regional courts have not yet ruled on or their rulings did not come into force.

\*\* Decisions issued with legal effect = this column also contains decisions on cases filed in previous periods that were processed during the given period.
