





What we have to keep in mind ...

- Cohesion policy = congestion of (too) many policy objectives, e.g.
 - Contributing to almost all EU policy goals
 - Highly innovative projects
 - Full absorption of EU-Funds
 - Easy access to funds for project owners
 - Highest possible evidence about correct use of funds
 - ...
- > many conflicting goals increasing complexity!

Why are ERDF-interventions as they are?

- **Extensive Framework conditions** of EU regulatory
- Multi-level approach means also multi-level regulations, audit & control
- Strong **restraints at operational level**
- This leads to increasing **risk averse funding behaviour** and reservations with regard to EU-funding
- The most innovative measures are implemented outside of the ERDF-framework

Four points to be emphasized

1. Division between strategic and operative tasks
-- > „**Agencyfication**“
2. **Balance** between formalization and informal coordination
3. **Active management** of project pipeline / implementation
4. Focus on **communication & coordination**
(horizontal, vertical) -- > ÖROK, STRAT.AT

Lessons learnt for 2014-2020

- Concentration of programme administration (from 9 to 1)
- Concentration of programme contents
- Strong focus on capacity-building (training, exch. of know-how, guidance for intermediate bodies, ...)
- Improve the legal basis, e.g. eligibility rules

- Nevertheless: build on the tradition of informal coordination!





Austria - Federal Republic consisting of 9 Federal States (Bundesländer)




Austria – Municipalities (2.357)



Spatial planning in Austria: legal-administrative frame

Distribution of legal competences (according to the Constitution)		
<p>I National Level: Sectoral policies & planning if explicitly mentioned, e.g. highways, railways, water, electricity <i>national sectoral laws</i> Art. 10 to 12</p>	<p>II States – Länder: Spatial Planning as not further mentioned policy agenda is given to the Länder <i>9 spatial planning laws</i> „Generalklausel“ Art. 15</p>	<p>III Municipalities Self-governmental rights in local spatial planning (under supervision of the Länder) Art. 118</p>

Institutional Framework in Austria


- **Planning at 3 levels:**
 - Municipalities (2.357),
 - Federal States (9),
 - National level
- *Bund* (national level) and *Länder* have competences for legislation and execution, *communities* have executive competences
- All three levels can launch private economic actions, e.g. run business support schemes etc.



➔ **Strong need for coordination and cooperation!**

Austrian Conference on Spatial Planning (Österreichische Raumordnungskonferenz, ÖROK)


- **Foundation:** 1971 – informal, but high-level steady conference
- **Members** (each of them stakeholders in Austrian (spatial) policy)
 - Federal chancellery
 - Federal ministries
 - Länder (provinces)
 - Association of Cities and Towns,
 - Association of Municipalities
 - economic and social partners
- **Organization:**
 - political board
 - several administrative sub-committees & working groups
 - ÖROK-office
- **Main Tasks:** Coordination of spatial planning and regional policy among the different governmental levels in Austria

ÖROK: Organisation & Products

- **Austrian Conference on Spatial Planning**
(*ÖROK, since 1971*):
 - Political agreement, no legal entity
 - Both political and administrative representation
 - Supported by secretariat/office
 - Basis: internal rules of procedure (Geschäftsordnung)
- **Main Tasks & Products:**
 - Coordination of measures with **spatial impact & regional policy**
 - Preparation of Austrian Spatial Development Concept (ÖREK)
 - Information exchange & knowledge transfer
 - Research (Studies on issues of spatial relevance)
 - Policy recommendations
 - Information & Publicity (Atlas, Reports, ...)
 - Spatial Monitoring – see www.oerok-atlas.at



Schema zum Verfahren des dreiteiligen Wettbewerbs mit Bürgerbeteiligung











Die politischen Spitzenvertreter der CENTROPE-Regionen in Pamhagen








(1) Zufriedenheit mit dem Wohngebiet (2003-2013)

F112: Und in Ihrem Wohngebiet?




(1) Zufriedenheit mit dem Wohngebiet nach Wohnbezirk (2003-2013)


