Reporting on Implementation of Development Plan for Combating Trafficking in Human Beings Reporting period 01.01.2007 - 31.12.2007

I. Assessment of implementation of the activities planned for 2007 in the development plan

The tasks which were planned for 2007 pursuant to the development plan have been completed. The development plan may be considered to be successful, since the network for combating trafficking in human beings and cooperation between different organisations functions more and more smoothly which guarantees better legislative proceeding of human trafficking cases and provision of assistance to victims. More and more specialists of different fields have been trained which has improved awareness in the field of human trafficking.

An amendment of the Aliens Act which prescribes the possibility of issuing temporary residence permits to victims of human trafficking entered into force on 1 February 2007. A significant change in the legislation in 2007 was an amendment in the Penal Code entered into force on 15 March by which the constituent elements of enslavement were supplemented (§ 133). Taking advantage of helpless situation of the victim or a dependent relationship with the accused is also deemed to be enslavement. In addition, the possibility of bringing charges against legal persons for enslavement is prescribed (see remark 10).

Surveillance information concerning potential cases of human trafficking is exchanged regularly with co-operation partners from Sweden, Denmark, Norway, Germany, Finland, Great Britain and Belgium. The information concerning potential cases of human trafficking is also exchanged with mediation by Europol liaison officers. In 2007 15 initial inquiries were submitted to the Central Criminal Police, some of them were followed by further exchange of information.

An initial description of the services provided to women victims of human trafficking for sexual exploitation in shelters for women has been prepared, 3 shelters for assisting sexually exploited women trafficked into foreign states were established and the rehabilitation centre Atoll established in 2006 continued its work. In 2007 the first victims of human trafficking used the services of the established shelters. Information materials are distributed (a pamphlet introducing the services of Atoll was completed), questionnaires related to human trafficking are completed and expert opinions are provided regularly.

Under the guidance of the Ministry of Justice, in cooperation with the Minister of the Interior, the Ministry of Social Affairs and the Ministry of Foreign Affairs analysis of the Council of Europe Convention on Action against Trafficking in Human Beings was prepared in 2007 which is the basis for the preparation of signing the Convention in 2008. The analysis of the Convention studies in more detail also the current and planned actions of Estonia in combating human trafficking pursuant to the standards of the Convention.

At the initiative of the Ministry of Social Affairs, an information campaign concerning the possibilities and risks of the labour recruitment system took place by means of printed media; the functioning of the labour recruitment system is analysed constantly. Training was provided to consular officers on the topic of identification of and providing assistance to victims and the

relevant instructions have been prepared for consular officers. A repeated study of the study of awareness of human trafficking of gymnasists planned for 2007 has been conducted.

A handbook intended for social workers and victim support officials for assisting victims of human trafficking has been completed in cooperation with IOM. Completion of the handbook is an example indicating that attention is paid not only to the detection and hearing of crimes related to human trafficking but also to the fact how to provide assistance to the victims of human trafficking.

The tasks requiring long-term activities are progressing continuously: organisation of the statistics concerning human trafficking is continued, coordinated cooperation takes place between the institutions and persons related to the field of human trafficking, numerous lectures have been organised for informing the public and training the specialists, two round table meetings have been organised for the cooperation network; active part is taken in international projects (the EQUAL project, the Nordic-Baltic Pilot Project) and in the work of the Council of the Baltic Sea States Task Force Against Human Trafficking.

In 2006, 3261 persons left their contact details with the Ministry of Foreign Affairs; in 2007 he number was 5609. The purpose for leaving contact details with the Ministry of Foreign Affairs is to ensure better consular protection. 250 people were assisted through hotline service of the non-profit organization Living for Tomorrow for the prevention of human trafficking (phone: 6607320) (see remark 3).

In summary: the round table meeting¹ held on 31.01.2008 in which the progress of implementation of the development plan was discussed stated that the second year of realisation of the plan had proceeded as planned and had been successful. A decision was taken to supplement the development plan with several new activities which so far had been pursued along with the planned activities and which addition to the development plan is caused by the developments in combating human trafficking in the two previous years of the implementation of the development plan.

These are practical guidelines which consist of the following chapters: how do victims find help, identification of victims, questioning victims, provision of advice to victims, practical observations and the most wide-spread problems of providing assistance to trafficking victims, cooperation between the police and the organisations providing social services, returning of victims. The manual has been published with the support of the Ministry of Social Affairs, the publication was financed by the Swedish International Development Cooperation Agency and the Embassy of the United States in Estonia. The printed matter will be published in spring 2008.

Explanatory remarks to the schedule:

1. Description of case

On 04 June 2007 Lucy Laitinen, an official of the International Organisation for Migration (IOM), notified the Ministry of Foreign Affairs that a victim of human trafficking (born in 1988) who is an Estonian citizen needed assistance in Great Britain for transportation into Estonia. In Great Britain assistance was provided to the girl through the Poppy Project (a Home Office funded project for identifying and providing assistance to victims of human trafficking). On 07 June 2007 the consul of the Estonian Embassy in London bought a plane ticket to M.T, after arrival to Estonia the victim was sent to the Tartu Women's Shelter. The Ministry of Foreign Affairs granted financial aid in the amount of 3395 kroons for transporting the victim home.

2. Qualitative study of gymnasists

It is a qualitative study of gymnasists conducted by the Socio Research Centre. The purpose of the study was to map the attitude of the youth in secondary and vocational schools to human trafficking, prostitution and going abroad to study or work. The aim was also to collect feedback concerning the campaigns for prevention of human trafficking carried out so far and to provide information for developing successful messages of new campaigns. In the course of the study 8 interviews were made with the target group -3 of them in Russian and 5 in Estonian schools, from among which half were vocational schools and half were upper secondary schools. The report on the study will be introduced in March 2008 at the seminar-training for teachers, youth workers and non-profit associations engaged in the prevention of human trafficking.

3. Overview of calls received by the hotline of the non-profit association Living for Tomorrow

In 2007 assistance was provided to 250 people through the hotline of the non-profit association Living for Tomorrow (phone 6607320) for the prevention of human trafficking. 57% of them were women, 43% were men. 18% of the callers were over 51 years of age, 15% were at the age of 31-35, the age groups 22-26, 27-30 and 46-50 formed 14% each. 4% of the callers were below 18 years of age. Education: 49% had vocational education, 23% higher education. 52% of the callers were from Tallinn, 12% from Harjumaa and the same percentage from Ida-Virumaa, 4% from abroad. 73% of the callers were Estonian citizens, 17% were stateless persons. 69% of the consultations took place in Russian.

People were interested in working in the following countries: Finland (24 cases), the United Kingdom (20 cases), Norway (14), Sweden (9), Spain, USA, Germany, etc. People called most often concerning the following jobs: any occasional work, builder, babysitter, unskilled worker, ship worker, driver, nurse, seller, engineer, administrator, waiter or waitress, volunteer. People called most often to receive information (78), on employment abroad (69), to verify the licences of companies (45), concerning employment contracts (24). Among the callers there were relatives who were concerned about persons close to them (18), people called concerning non-payment of wages (12) and obtaining residence permit either in Estonia or abroad (9). Three times advice was required in connection with criminal proceeding related to human trafficking, three times people called concerning a missed person.

Hotline was also used by officials from Estonia and abroad for obtaining information concerning the general situation, for receiving contacts of organisations providing assistance, etc. 27% of these calls came from abroad, 73% from Estonia. The biggest number of calls came from specialists (31%), journalists (18%) and officials (13%). Students, diplomats, policemen and youth workers called also.

In summary it may be said that the counselling service is very necessary. In addition, counselling service is provided also on the website <u>www.lft.ee</u>. The non-profit association Living for Tomorrow has been financed additionally by the Gambling Tax Council thanks to which lectures have been delivered in schools on the topics of safe working and studying abroad (24 groups of gymnasists/students of vocational schools, 5 groups of adults). Cost 180,000.-

4. Anti-trafficking training for specialists engaged in the prevention of and fight against human trafficking and assisting trafficking victims

In 2007 the Ministry of Social Affairs in cooperation with non-profit associations conducted 5 trainings on the topic of the prevention of human trafficking and providing assistance to the victims. 2 trainings with Living for Tomorrow – in Jõhvi (20 participants) and Narva (11 participants), in Russian. The target group was social workers and victim support officials, policemen, school psychologists, child protection officials. 2 trainings with ENUT – in Tallinn (60 participants) and Narva (60 participants), in Estonian. The target group was border guards (in the framework of the EQUAL project). For the first time the target group was border guards whose training is very important in terms of identification of a victim already at the border. 1 training with the non-profit association Lifeline – in Narva-Jõesuu (20 participants), in Russian, for the support persons of the persons engaged in prostitution.

During 2007 ten lectures were delivered by the Ministry of Social Affairs to 438 people (100 of them were officials and non-profit organisations of the Nordic countries and the Baltic States). The target group was the local governments and state officials, non-profit associations, employees of shelters, consular officers, policemen, youth workers, women's organizations and support persons. Most of the lectures were delivered in Tallinn. A series of lectures of Living for Tomorrow was financed through the Gambling Tax Council – in 2007 24 lectures were delivered to groups of students of secondary and vocational schools and 5 lectures to adult groups.

The Ministry of Social Affairs has been very flexible in planning the trainings and has proceeded from the current requirement; training has been provided to the target groups who have expressed their desire for training. Training of Russian population in cooperation with LFT has been especially important. In 2007 the total cost of trainings, lectures and seminars with the participation of the Ministry of Social Affairs was 161,932.-

In 2007 members of the national network of combating trafficking in human beings participated in the following trainings and seminars:

One official of the Ministry of Foreign Affairs participated in the meeting of the Council of the Baltic Sea States Task Force Against Human Trafficking on 22 March 2007 and one official on 5 December 2007 in Bonn and Riga respectively.

14.02.2007 - the European Community initiative EQUAL project "Integration of women involved in prostitution including victims of human trafficking into the legal labour market". Organiser: the Estonian Women's Studies and Resource Centre. Target group: police officers of the North Police Prefecture, 20 officials.

14.02.2007 - the European Community initiative EQUAL project "Integration of women involved in prostitution including victims of human trafficking into the legal labour market", organiser: the Estonian Women's Studies and Resource Centre. Target group: police officers of the East Police Prefecture.

On 10 April 2007 an official of the Ministry of Social Affairs delivered a lecture to consuls on the topic of human trafficking.

From 23 to 24 May 2007 the IOM organised a seminar in Tallinn on the topic "Counter-Trafficking Capacity Building for Law Enforcement Officials in the Baltic States – Investigation and Prosecution of Human Trafficking", in which 16 policemen, 2 officials of the Ministry of Justice, 2 employees of the Tax and Customs Board, 6 employees of the Citizenship and Migration Board, 16 employees of the Border Guard Administration took part.

From 30 to 31 May 2007 5 policemen, 2 employees of the Border Guard Administration, 1 employee of the Citizenship and Migration Board, 2 prosecutors participated in the IOM conference Law Enforcement Against Trafficking I Human Beings: From Sporadic Investigations to Specialized Counter-Trafficking Units in Vilnius.

From 11 to 15 June 2007 - planning of regional police work and criminal prevention (including prevention of minors falling victim to prostitution and trafficking), the Police Board, target group: security police officers.

From 18 to 19 June 2007 - Prevention of human trafficking and providing assistance to victims. The Ministry of Social Affairs, target group: security police officers of the East Police Prefecture.

In summer 2007 in the discussion of the United Nations Convention on the Elimination of All Forms of Discrimination Against Women in Estonia the topic of human trafficking was covered both orally and in written replies. The officials of the Ministry of Foreign Affairs, the Ministry of Social Affairs and the Social Affairs Committee of the Riigikogu participated in the discussion.

On 26 June 2007 a seminar of the network for combating human trafficking with a round table meeting was held in the Embassy of the United States of America in Tallinn in order to provide information on the topic "Estonians seeking work abroad", which was attended by the Ministry of Social Affairs, the Ministry of Justice, the non-profit association Lifeline, Vega Centre, ENUT, the Foundation for Lifelong Learning Development, the Labour Market Board, the Finnish Trade Union representative in Estonia, the non-profit association Living for Tomorrow, EURES and representatives of the Embassy of the United States of America.

From 4 to 5 September 2007 one representative of the Border Guard Administration and representatives of non-profit associations participated in the international conference "Support, Protection, Rehabilitation of Women Victims of Trafficking in Human Beings " in Vilnius, Lithuania.

One official of the Ministry of Foreign Affairs participated in the human trafficking seminar organized by UNESCO in Tallinn in September 2007.

On 12 November 2007 a seminar with a round-table meeting for members of the national network of combating trafficking in human beings was held. The coordinator of the Plan of Action to Combat Human Trafficking of the Ministry of Justice of Norway, a preliminary investigator of the Stockholm police, a representative of the Norwegian ROSA project for providing assistance to victims of trafficking delivered lectures at the seminar. In addition to the training, a seminar was organised in connection with the meeting of the national network.

From 13 to 14 November 2007 – Trafficking and sexual exploitation of children and young people, Tartu Child Support Centre; target group: security police officers of the East Police Prefecture.

From 20 to 27 November 2007 an official of the Ministry of Social Affairs studied the work against human trafficking in Iceland through the civil servants exchange programme of the Nordic Council of Ministries. The report of the study trip has been submitted to the members of the network.

From 3 to 7 December 2007, 2 prosecutors, 2 policemen, 1 employee of the Ministry of Justice and 1 employee of the Border Guard Administration participated in the study trip intended for employees of law enforcement authorities which took place in Ukraine, Kiev and was organized by the IOM. The report of the study trip is being completed and it is intended as supporting materials for other employees of law enforcement authorities.

From 5-6 December 2007 two employees of the Ministry of Foreign Affairs, a representative of the Embassy in Riga, a representative of the Estonian Consulate General in St Petersburg participated in the training of the consular agents in Riga organized by the Council of the Baltic Sea States Task Force Against Human Trafficking.

From 6 – 7 December 2007 - Trafficking and sexual exploitation of children and young people, Tartu Child Support Centre; security police officers of the East Police Prefecture.

2) Printed information material "How to seek and find legal work?"

3) The Atoll centre has concluded 28 rehabilitation contracts, 13 women have proceeded to the labour market in the I half of 2007 (data on the I half year; data on the II half-year will be completed by February)

4) Study of the Estonian Open Society Institute which was conducted among 75 women engaged in prostitution who have been involved in the system of the Atoll centre and support persons.

5) The manuscript of the book "Voices of the Silent III) has been completed.

6) International cooperation:

The main results of the international project "Headway - Improving Social Intervention Systems for Victims of Trafficking" conducted in the framework of the European Union's Equal programme 1) the comparative analysis of the research on human trafficking; 2) the comparative analysis of the legal aspects of human trafficking of partner countries; 3) examples of best practices in the prevention of human trafficking and provision of assistance to the victims; 4) a uniform model for monitoring human trafficking has been developed; 5) an online database (www.osservatoriotratta.it/headway) has been completed for promoting information exchange between the organisations engaged in assisting the victims of trafficking.

7) International conferences on human trafficking: in February 2007: international conference of the Equal programme on the topic "Trafficking of Women to the European Union: Problems and Solutions"; in the framework of the international conference in Tallinn in February 2007 an art and multimedia exhibition "Body Market" was opened; in April 2007 the conference "Social Inclusion of labour migrants – an Effective Anti-Trafficking Strategy?" was held in Berlin; in June 2007 the final conference of the project "Improving Social Intervention Systems of Victims of trafficking. The role of monitoring systems and multi-agency approach" was held in Rome. The final report of the Headway project is available also by electronic means at the address www.osservatoriotratta.it/headway.

6. In 2007 three shelters for assisting women trafficked for the purpose of sexual exploitation were opened in the framework of the Nordic-Baltic Pilot Project. The shelters are located in Tallinn, Tartu and Ida-Virumaa. There are 2 beds in each of them, thus, the total of 6 women can be accommodated at the same time. 4 women needed accommodation during the year.

A common phone number 56240606 was opened for the shelters; through this services for victims returning from abroad are coordinated. The pamphlet introducing the services and the pilot project has been distributed actively at the conferences and other meetings abroad with a request to the representatives of the Nordic countries to inform us of the victims from Estonia.

The employees of shelters were trained during the whole year; the employees of the *Living for Tomorrow* hotline and the Atoll rehabilitation centre were involved in some of the trainings.

A study trip to Norway took place from 5 to 9 February. The work of the Rosa project was studied, two shelters providing assistance to trafficking victims (in Gjövik and Indre-Östfold) were visited, the representatives of the women's shelters of Northern Norway were met in Oslo, the representatives of the General Police Directorate, the IOM and the Ministry of Justice were met. A visit was also paid to the Nadheim centre in Oslo which provides assistance to prostitutes.

A study trip to Stockholm took place from 15 to17 March. The women's shelters in Sollentuna and Järfälla, the helpline for young women in Stockholm and the biggest women's shelter Alla Kvinnors Husi were visited. Police officers, a prosecutor and representatives of Stockholm City Government dealing with the cases of human trafficking were met.

A training was conducted on 1 April in Tartu by a women's shelter in Lithuania; an apartment rented and furnished recently for the shelter of victims of human trafficking with the support of the Nordic-Baltic Pilot Project and the Gambling Tax Council project was visited.

A training from 14 - 15 April in Tallinn, the training providers were from the Reden-Stop Kvindehandel in Copenhagen and they introduced the work of their centre and the experiences of Denmark upon providing assistance to the victims of prostitution and trafficking.

A training on 26 May in Tallinn, the training providers were from the centre Marta in Riga which is engaged in providing assistance to women who have fell victim to human trafficking in Latvia.

7. Estonia has been member of the Council of the Baltic Sea States Working Group for Cooperation on Children at Risk since 2002. Activities are continuous. There is no deadline for the project, as it is a form of co-operation involving exchange of information and experience and, furthermore, specific projects are carried out.

8. Shelters of victims of human trafficking

Employees of the shelters for victims of human trafficking have been involved as experts for determining the needs of and services for the victims of human trafficking. An overview of the required services was provided at a round-table meeting held in the Ministry of Social Affairs. According to specialists, victims of human trafficking require an accommodation service which is closely connected with good availability of medical and psychological services. It is also necessary to receive the abovementioned services for a longer period and sometimes it is necessary to receive the services very quickly. The development of a more detailed package of services is a longer process.

So far the shelters for victims of human trafficking have received support from the Nordic countries through the Nordic-Baltic Pilot Project and the Gambling Tax Council. Since 1995 it has been attempted to decentralise the whole system of social welfare, i.e. the services shall be provided on the spot and together with other services provided by the local governments, thus, the shelters for victims of human trafficking shall also be organised by the local governments. The local governments have the obligation to organise, they do not have to provide the service themselves but they can buy it from different organisations. Since the local governments are not completely ready to organise the provision of the service, it is necessary to provide training to them.

9. Cases presented to the children's helpline or reasons for addressing fall in two main categories by nature: addressing of cases and provision of information.

Cases are referred either to the social welfare department of the city district (hereinafter social welfare department), the Rescue Board, the police, trust lines or a shelter. If other place than the social welfare department has been contacted (for example, outside of working time), the social welfare department shall also be notified of the case at the earliest opportunity.

In the case when *need for information* is expressed, information from the children's helpline data bank is provided to the person, or the call is referred to the agencies who have information concerning their area of activity who will provide the necessary information to the person.

10. Amendments to legislation

Amendments in the Penal Code entered into force 15.03.2007.

The constituent elements of enslavement in section 133 of the Penal Code were supplemented on the basis of the definition of trafficking in human beings set out in the Council Framework Decision of 19 July 2002 on combating trafficking in human beings (2002/629/JSK). Taking advantage of helpless situation of the victim or a dependent relationship with the accused is also deemed to be enslavement. In addition, the possibility of bringing charges against legal persons for enslavement is prescribed.

The definition of enslavement in section 133 of the Penal Code included only violence or deceit as possible ways of enslavement, thus the ways of enslavement of trafficking specified in the Framework Decision were not covered. The cases where violence or deceit is not used were not covered. Therefore section 133 of the Penal Code was supplemented by the feature,,by taking advantage of the helpless situation of the person" which should comply with Article 1 (1c) of the Framework Decision. The helplessness (capacity to resist or understand) of a person shall be assessed based primarily on the person's age and mental state. In case of minors it shall be taken into account that their knowledge of working or sexual behaviour might not be sufficient in order to understand the nature of the job offered and their rights. In addition, they can usually be more easily influenced by other persons, especially if they are in a family-related, economic, or any other dependent relationship with that person (parents, caregivers). A person is in a helpless situation also if he or she is unconscious or severely intoxicated. A helpless situation may be connected with the dependence of the victim on the offender (e.g. a parent or a legal representative and a child; a doctor and a patient). Here taking advantage of helpless situation may mean offender using his or her power, threatening to use his or her power or creating intentionally such fear in the dependant without violence and in this case it really should be a situation where a person has no actual alternative to obeying. For example it does not include a case where a superior gives an employee an order to work overtime by threatening to fire the employee, if he or she fails to do so.

The Framework Decision provides also that liability of legal persons shall be prescribed for criminal offences specified therein (e.g. an undertaking which uses the work of trafficked persons by force or a mediator of employment who supports trafficking in human beings); therefore sections 133 and 134 of the Penal Code were supplemented by liability of legal persons.

Amendments in the Penal Code entered into force 1.02.2007

By the amendments the fine to the extent of assets was repealed and replaced by the institute of extended confiscation of assets acquired through criminal offence in § 83² of the Penal Code. The court shall impose extended confiscation of assets in case of such sections on human trafficking as enslavement, disposing minors to engage in prostitution, aiding prostitution involving minors, provision of opportunity to engage in unlawful activities and aiding prostitution. Provision of basis for extended confiscation of criminal income in the Penal Code establishes bigger opportunities for confiscation of property obtained from criminal activities.

Extended confiscation may include the total value of all the assets of the convicted offender if there is reason to believe that the entire property has probably been obtained as a result of criminal behaviour. This may be indicated by the difference between legal income and actual life standard, the nature of the committed crime. The offences which may be accompanied by extended confiscation of income upon conviction are also offences aimed at the receipt of economic benefit which therefore may be assumed to have been committed also earlier.

Amendments of the Aliens Act and the Obligation to Leave and Prohibition on Entry Act^2 which prescribe the possibility of issuing temporary residence permits to trafficking victims entered into force on 1 February 2007. With the amendments Council Directive 2004/81/EC on the residence permit issued to third-country nationals who are victims of trafficking in human beings, who cooperate with the competent authorities was transposed.

III. Overview of funds used for implementation of activities (01.01.2007-31.12.2007)

All costs necessary for implementation of the Development Plan shall be prescribed and planned in the budget of the relevant Ministry. The activities necessary for the implementation of the Development Plan can be divided into two groups according to their financing.

The first group contains activities financed within the framework of the operating costs of Ministries and agencies within the area of their administration. The schedule for implementation (see Chapter II) contains an overview of activities which were financed from operating costs for 2007.

The second group includes activities financed for the specific purpose of dealing with the problem of human trafficking.

The following table sets forth the division of the costs of the measures/activities which were specially financed for the purpose of combating human trafficking in 2007
