Transport of firearms or ammunition through this completed form shall not be notified later than 1 hour before the beginning of the transport to the appropriate department of the Police of the Czech Republic or Police Presidium. Completed form and its enclosures shall be sent by e-mail (see the note No. 2). Hard copy of this Notification shall accompany firearms or ammunition to their destination and shall be presented to the Police or Customs upon request.

¹⁾ *In the case of alteration of already notified transport person can change only data about transporting firearms/main parts/ammunition, date and time of the expected start and end of the transport, data of the transporter, route of transport, vehicle or person responsible for the transport. Alterations shall be notified no later than before the end of the transport.*

²⁾ *Appropriate authority to receive Transport Notification is*
- Regional Directory of the Police of the Czech Republic according to the domicile or seat of the holder of the Firearms Licence, who is seller of buyer, or
- Police Presidium of the Czech Republic (in case the notifier is foreigner).
